# DEAD BODY FOUND BENEATH MASS OF MOUNTAIN DEBRIS

FRANK MARTIN VICTIM OF ACCI-DENT WHILE MINING ON RIVER.

#### SLOWLY BLED TO DEATH

PINNED BENEATH ROCK MASS, AWAITED COMING OF CER-TAIN DEATH.

Lying in a pool of blood, with both arms and legs crushed and one arm nearly severed from his body, as the result of being pinned beneath a slide of lava rock, Frank Martin, a well-known resident of Enterprise, was found dead by his wife, at the junction of the South and Middle Forks of the Feather River, about midnight last Wednesday.

Martin had been crevicing along the two streams for some time past, and was working about five miles below Enterprise when he met with the accident.

# FALLING ROCK KILLS MINER TRAGEDY DISCOVERED BY WIFE

When he did not return home for supper Wednesday evening his wife became alarmed and thought that something must have happened to him. She notified an Indian, by the name of John Pinkie, who was living near the Martin home, and together they started out to find him. His wife knew about where he was working, and at about midnight he was found, half-buried under the lava rock.

He had evidently been mining the dirt away from beneath the pile of rock, when without warring the rocks broke loose and the tons of debris piled on top of him. The largest rocks feli on his arms and legs, although a few smaller ones fell on his waist. There was only one scratch on his head, which would lead to the conclusion that he must have been conscious and that he was aware that he was slowly bleeding to death from the deep gash that was cut in his arm by the falling debris. Both legs and both arms were broken.

Coroner John Wallaco and Deputy Coroner Hamilton went to Enterprise from this city yesterday, and held a coroner's inquest over the remains. The jury returned a verdict that death had been caused from hemorrhage, occasioned by falling rock. It was necessary to carry the body about two miles to where it could be put in a wagon.

Martin had been a resident of Enterprise all his life. He was an Indian, but was respected by all those who knew him, both whites and Indians.

The funeral will be held this afternoon at Enterprise. Burial will be in the Indian burying ground at Oregon Creek.



### Henry H. Yard Passes Away in San Francisco

Henry H. Yard, the prominent well known railroad and mining man, formerly of Oroville, died in San Francisco last Friday after an illness that had confined him in St. Winfred Hospital for nearly seven months. Mr. Yard was well known in Plumas county as a prominent promoter and owner of the Butte and Plumas Railroad and participated in the movement which resulted in the construction of the Western Pacific Rullroad in this section of territory. Henry H. Yard, organizer of the North California Mining company and well known in Butte and Plumas counties, the scene of his operations, passed away at the St. Winnifred hospital in San Francisco last Friday. Mr. Yard was a man of very pleasing personality, and of great intelligence. He was an indefatigable promoter.

## NOTED MAN OF MINING TAKEN.

One of Guggenheim Group

Dead in this City.

Andrew Beatson, Once Owner of the Big Bonanza.

Much of Alaska's Copper is a Monument to Him.

After a lingering sickness of several months, Andrew K. Beatson, associated with the Guggenheims in valuable Alaskan mining properties and president of the Fifty Associates, a California corporation, died yesterday morning at the California Hospital. He had been residing at the Hotel Melrose. A pioneer in the development of mining in Alaska, he was also well known in mining circles of the West. He came to California with his parents in 1858 and engaged in the mining business as a very young man.

The early years of his career were the usual ones of a mining man, many hardships, failures and disappointments coming with the few trivial successes. In 1881 he was appointed superintendent of the Big Bend Tunnel and Mining Company, of which Dr. R. V. Pierce was the head. mained with this corporation for a little more than ten years and supervised the construction of the 12,000foot tunnel which now drains Feather River and is the source of power for the Great Western Power Company, operating in the San Francisco Bay district.

Having heard of the wealth of minerals in Alaska, he went to that Territory in 1896 and less than a year later discovered and located the Blg Bonanza group of copper claims on La Touche Islands. He immediately began the development of the property and, with the assistance of the late Andrew Robertson of New York, succeeded in acquiring all of the claims and interests on the islands. In 1910 a new incorporation of the property

was made, the Guggenheim interests having taken over a large share of the stock and the company was given the name of the Beatson Copper Company, with principal offices in New York City.

Shortly afterwards, Mr. Beatson retired from the active management of the company and from business life. With his wife he passed several years in travel, coming to Los Angeles finally to make his permanent home. Early in 1914 he was induced to re-enter business with the new incorporation, the Fifty Associates, a company dealing with the financing of commercial enterprises. Because of his extensive experience in the business world, he was named president, a position he occupied at the time of his death.

Mr. Beatson was a native of New York City. He was born July 7, 1854, the son of Dr. and Mrs. James Robertson Beatson. He married late in life Miss Flora MacDonald, the wedding having taken place on October 7, 1908. His widow, in addition to a brother, James Beatson of Los Angeles, and a half-sister, Miss A. Gregory, residing in Oakland, are the only near relatives who survive him.

The exact size of his fortune is not known, even to Mrs. Beatsen. It is largely invested in stocks and bonds. The Los Angeles Trust and Savings Bank has been named executor of the state, which will be settled immediately.

The funeral service will be conducted tomorrow afternoon at 2 o'clock in the Pierce chapel, No. 810 South Flower street. The body, in fulfillment of his last wishes, will be reduced to ashes at the Los Angeles Crematory.

#### WENDELIN MILLER IS DEAD

CHICO, December 28.-Wendelin J., Miller, president of the First National Bank of Chico extensive rancher and stockman and one of the wealthiest, most enterprising men in Butte county, died at 3:15 yesterday afternoon in the Lane hospital, San Francisco.

He was in the prime of an energetic, useful life, having been fortyone years old August 27, last.

Death came after an illness of practically three years. In little more than two years he had undergone two capital operations and two minor operations; the last of which was pertormed in San Francisco last Tuesday.

Miller is survived by his widow. She and her nephew, J. E. Holub, were him when death came.

Miller had been one of the most active men in Butte county, mentally and physically. He was a prodigious worker and personally directed his wide and varied interests.

He had been president of the First National Bank of Chico for four years and was a director of the People's Commercial and Savings Bank.

He owned a fine ranch of 1200 acres a few niles south of Chico, on which he made his home for ten years up to the time he came to Chico to reside four years ago His other holdings included a tract of 2100 acres in Glenn county, 8000 acres of grazing and ferming land near Pentz, and a half interest in the Union Hotel property in Chico.

As well as being a large raiser of cattle, he also was an extensive trader in stock. He also gave some share of his attention to the breeding and training of racing harness horses. He owned Capitola and was half-owner of John Malcolm, both champion pacing colts on this coast.

A'though a young man when death came, for more than twenty years he had been active in the direction of large affairs. When but twenty-one years old he assumed active management of the estate of his father. Joseph Miller, and his uncle, Wendelin died at the age of four years.

Miller. In those years he greatly increased the Miller estate

Miller, enterprising and energetic, was a producer His wealth always was active and, believing in the future of Butte county and the Sacramento valley, he invested his capital here. His life was an example which any young man might well follow. He was honest and upright, his word was his

He was a man of warm impulse, true to his friends and whose great wealth developed no unpleasant characteristics. It was characteristic of him that he always had a word of encouragement and a helping hand for his friends of his boyhood.

As a citizen, he was one of whom any city or town might well be proud. He supported many civic ments and his progressive idea brought him to the front rank of projects looking toward municipal improvements, as well as of business enterprises which fathered community development.

In national politics he was a Democrat and in his fraternal relations he was a member of Chico Lodge of Elks and the Woodmen of the World of this city.

Miller was born August 27, 1873, at Frenchtown, Butte county, near Yankee Kill. His father, Joseph Miller, was a native of Germany, who came to the United States in 1856 and to California in 1858, becoming a pioncer stockman and butcher of Butte county. His father died six years ago. Miller's mother was Juliu A. Benjamin, a native of Wales, who died in Chico almost two years ago.

Miller's boyhood days were spent in Butte county and his early education was received in the public schools. In 1889 he graduated from the Garden City Business College in San Francisco and a few years later took up the active management of the Miller esvate.

He married Susie Sturmer in Cherokee. One child was born, Mae, who
