David H. Williams, a pioneer mining man of Butte County, died at the home of his son-in-law and daughter, Judge and Mrs. J. V. Parks, at 1718 Pomona avenue, Tuesday night at 11 o'clock.

Death was not unexpected as Mr. Williams had been an invalid for the past two years, and had been confined to his bed since last November.

Mr. Williams was a native of South Wales, being born there on the second day of April, 1852, and at the time of his death was 66 years, 10 months and 2 days old.

When an infant he came, with his parents, to the United States, coming

to California via Cape Horn.

Immediately after the family arrived in San Francisco, they moved to Cherokee, where he grew to manhood, receiving his early education in the public schools there. At the age of 26 years, Mr. Williams was united in marriage to Miss Ada Jones of Cherokee, who died two years later. One child, Mrs. N. L. Crebassa, of San Francisco, survives this union.

On September 6, 1886, Mr. Williams was married to Miss Annie J. Jones,

of San Francisco.

Mr. and Mrs. Williams made their home at Cherokee for many years, where Mr. Williams was engaged in farming, stock-raising and mining. In October, 1907, the family moved to Oroville, where Mr. Williams was engaged for a number of years in dredge building. He was sent to Mexico and Central America on several occasions to expert and report on mining properties in those countries.

KILLED IN FRANCE

Grover C. Evans of Weed Dies in Railroad Accident Near St. Nazaire

WEED (Siskiyou Co.), April 17.— Letters have been received here in further explanation of the death of Grover C. Evans of this city, who was instantly killed in a railroad accident in France on March 2nd, while serving with the American Expeditionary Forces.

A letter from B. C. Cramer, who served with Evans in the Twentieth Engineers or Second Forestry Regiment, says the local man was killed while en route from St. Nazaire, France, to Camp Aurielham, where that part of the regiment to which most of the Weed soldiers were attached were to take charge of a sawmill.

Killed as Step Breaks.

Cramer reports the accident occurred as they were leaving the station, when a car step broke and precipitated the soldier beneath the wheels of the train.

Evans was a member of Company D, Second Battalion, and left here with a number of Weed soldiers in 1917, who were headed by Major S. O. Johnson of the Weed Lumber Company. He was a native of Butte County, aged about 20 years, and was working as locomotive engineer for the Pelican Bay Lumber Company at Klamath Falls immediately before his enlistment. He formerly was employed by the Weed Lumber Company.

His father, J. C. Evans, resides here. His mother, two sisters, and a brother

also survive.

SHORT HISTORY OF DECEASED 49ER IS TOLD

The following account of the life of Alman Beavers, one of the '49ers of Butte county, who passed away a few days ago, has been submitted by Mrs. Edith Jensen, of Berry Creek:

The death of Almon Beavers, the aged pioneer, who was buried July 2, revives much of California's early history in the minds of his old friends.

Mr. Beavers was born in North Carolina, moving with his parents to Texas when but a boy, from that state he came to California in 1853 and was affectionately called "Texas" Beavers by his friends on account of coming to California from that state.

Fifty years ago he conducted a buitcher shop in partnership with Mike Kesselring at Peavine, now known as Merrimac, a stage station and postoffice on the Oroville and Quincy road. In those days mail

was carried on dog sleds over the mountains in winter and Mr. Beavers often told of "Buck" Whiting, father of E. C. Whiting and Capt. Frank Whiting, carrying the mail in this fashion and coming to his butcher shop after a hard trip in the snow and buying the best cuts of meat to feed his dogs.

About this time he married Mary, the daughter of the Chief of the Peavine tribe, who still survives him. Two sons and two daughters were the result of this union; a son Alfred L. Beavers, and an infant daughter, preceded the father to the great beyond; besides his wife he leaves to mourn his loss, his son. Allsey Beavers, of Chico, his daughter, Mrs. Stacie M. Walsh of Oloville, two granddaughters, Weaver and Miss Walsh, six grandsons, Harold Almon B., and Alfred L. Beavers, Charles, Alvin and Jimmie Walsh. and an infant great-granddaughter, little Watt Thomas Weaver.

Mr. Beavers was a man of sterling worth and respected by a host of friends.

Highly Respected Citizen of Hanover Township Passes Away December 24th After a Long Illness

LEAVES WIFE AND ONE SON

Funeral Services Were Held Saturday, Rev. Wm. Frese Officiating—Interment in Hanover Cemetery

Henry Tebbe, highly respected citizen of Hanover township, passed away on Wednesday morning, December 24th, at 2:45 o'clock, after an illness of three weeks' duration, at the ripe age of 72 years. Mr. Tebbe has not been in the best of health of recent years, suffering with stomach and heart trouble, and it was this trouble which was the immedi-

ate cause of his death.

He applied himself to such good purpose that he was able to purchase land as time advanced so that he acquired considerable holdings. Mr. Tebbe improved his land and was considered one of the best farmers in that sec tion of the county.

On the 25th of February, 1885, Mr. Tebbe was united in marriage to Miss Sophia Wiese, who was born in Germany, Sept. 13, 1863. There were four children born to this union, three of whom, Elizabeth, Matilda and John, died in infancy. Albert W., the eldest, was born March 15, 1887, and is still living at home. For the past few years Albert has been the mainstay of the family, practically managing the farm on account of his father's failing health.

Besides the devoted wife and son, Mr. Tebbe leaves to mourn his death one brother, John Tebbe, of Kenwood, and five sisters, Mrs. George Busch, Clinton county; Mrs. William Kuchn, Clinton county; Mrs. August Kuchl, Clinton county; Mrs. Lonard Zogg, residing in Wisconsin, and Mrs. Henry Busch, Clin-

ton county.

Mr. Tebbe's interests were thoroughly identified with those of Hanover township and no man in the township was more willing to assist in its advancement. He was of a modest, retiring disposition and therefore never sought publicity, prefering to devote his time and attention to his family and farm. He was a man held in high esteem by all with whom he came in contact, and in his death Hanover township and Crawford county has lost a good citizen, kind friend and neighbor.

Funeral services were held Saturday afternoon at 2 o'clock from the late home, Rev. Wm. Frese, pastor of the Lutheran church in Denison, officiating, after which interment was made in the

Hanover township cemetery.

Deceased continued his mining here until 1862 when the big flood of that season wiped out his holdings. Pans taken from the river bar during the eight years he mined there averaged \$2,000 a week in gold.

His next operations in mining were as superintendent of the famous Cherokee mine and the world was tery.

Later Mr. Dyer mined on the Magalia Ridge, and later entered the employment of Major Frank McLaughlin and was superintendent of his operations along the Feather river.

He was married in 1878 and is survived by his widow and one son, Geo. S. Dyer, who is now in charge of mining properties in Siberia.

Deceased was a member of Oroville Lodge, No. 103, F. & A. M., serving as Tyler. He was also a member of the Royal Arch Masons, Knights Templar and a member of the Eastern Star.

To their last resting place in the Paradise cometery, the remains were followed by many prominent pioneers whose names were household words in the early days, when they led their follow citizens in wresting a competency from the country when it was part of the undeveloped frontier,

The old timers, members of that ever-diminishing vanguard, recognized the fact that yesterday they returned to the soil she leved to well the last surviving member of a family whose home, the Pence ranch, twelve miles east of Chico, was one of the principal social centers of the country.

"Mrs. Pence is gone," said one ploneer, "but the Pence spirit will last
as long as the country. Her contributions to theause of education, has

Yesterday's services took place a short distance from the spot where the late Mrs. A. (Thankful) Lowis Carson of Chico and hrtowo brothers, Jimmy, then 11 years old, and Johnny, then aged 6 years old, were captured by the Mill Creek Indians, while they were drinking out of Little Dry Creek, near the Cherokee road. Mrs. Carson escaped from the Indians, but her brothers were separated and later found dead on the readway a few miles from the scene of their capture.

It was the story which this girl of 6 years told at the Pence home that resulted in concentrated action on August 1, 1863, which cleared the country of all Indians.

NOTED PIONEER WOMAN IS DEAD

Sophia Pence, Butte County ploneer, died Tuesday at her home in Paradise, at the age of 93 years.

Mrs. Pence was one of the most notable of Butte County pioneers and one of the last, if not the last, of the women of early days who came to this county before the Civil War. She was the widow of M. Pence after whom the old town of Pentz was named, and she and her husband conducted for many years a hotel at that place.

This hotel in the early days was a famous stopping place of the overlang stages en route to the mountains of Butte, Plumas and Lassen Counties. It was destroyed by fire some years ago, after the death of Pence.

Mrs. Pence was a woman of education, culture and wide reading. She was a writer of considerable ability and the county papers of years ago often contained articles and poems from her pen. After the death of her husband the ranch and hotel at Pentz were sold and she removed to Paradise, where for many years she was highly esteemed.

Deceased is survived by no immediate relatives. Her only son, Watt Pence, died about two years ago.

Veteran Stage Driver, Pioneer of Butte, Is, Dead

veteran stage Luther Sherman, driver, who passed from active service when the automobile succeeded the horse, died at his Fourth street home Sunday. Sherman was known every early pioneer in Northern Callfornia as a driver who was master of the most delicate situations. He substituted his wits for his gun in dealing with stage robbers and he made Black Bart a would-be in one instance.

Sherman was 78 years old. Born in Waterford, Pennsylvania, he came to Colifornia eight years after his marriage, September 12, 1865. Arriving in Marysville, he purchased a stage line from his brother, Charles Sherman, and for a number of years he drove on the Marysville, San Juan and Nevada City line, carrying the bonanza offerings of the rich gold mines in that vicinity.

Later he drive from Marysville to La Porte and then moved to Chico, where he operated lines to Prattville, Orland and Susanville. He also operated busses for the Park and Diamond hotels and owned a livery stable located on the corner where the Municipal building now stands. On all the stage routes he carried the mails under contract.

It was while he was on the run out of Marysville that he met the stage robber who afterwards proved to be Black Bart. He was driving along in a buckboard with the mail and express box, there being no passengers. The robber jumped from behind a tree and pointed a gun at Sherman.

"What do you want," said Sherman. "Your money," said the robber.

"Well I've only a half-dollar and no money for dinner so you can't ask more than a quarter," said the driver, tossing the 25 cents in the direction of the masked bandit and driving on. The robber disappeared and the express and mail was untouched. In all his staging experience his rig was only held up once, and the robbers were never captured.
