BUTTE INDIAN IS KILLED BY AUTO

F. H. Kroepelin Passes Away



I haven't got a papers but still even in death I am with you.

Auto Crashes Endangering Other Lives

CHICO — (Special) — An autopsy performed this afternoon disclosed that Jacob M. Sturmer, 67, had died of a heart attack at the wheel of his car which caused it to swerve and crash into a fence on Chico road this morning.

On his way to Oroville to attend funeral services for Frank Holub, his brother-in-law, Jake Sturmer, of Chico, died at the wheel of his automobile as it crashed into a stone fence on Oroville-Chico Road about 9 a. m. today.

His wife and Mrs. Susle Miller, also of Chico, escaped serious injury as the car swung across the road out of control, struck the fence and turned over.

Sturmer was pinned in the automobile, and it was necessary to raise the machine from his body.

Body Taken To Chico

Belief was expressed that death may have been caused by heart disease, which struck as he sat at the wheel of the car. He was stricken as the car reached a point near the junction of the Neal Road to Paradise and the Oroville-Chico Road.

C. L. Meline, county welfare agent, on his way to Oroville, removed Mrs. Miller and Mrs. Sturmer to Chico. Sturmer's body was taken to the H. C. Bicknell Funeral Home in Chico, where it is anticipated an inquest will be held to determine the cause of the accident and whether Sturmer died from a heart ailment or merely fainted or dozed at the wheel of his car, dying from injuries received in the crash.

Saw Auto Swerve

Meline said he believed that Sturmer may have been dead when the car struck the fence. The welfare agent said he did not believe a blow on the head received in the accident would have been sufficient to cause death.

"I was driving about a quarter mile behind the car when I saw it swerve suddenly, strike the fence and tip over on its left side," he said. "Up to that time the machine had been going straight along the highway."

Meline said he hurried up, and with the assistance of two men who were operating a tractor in a nearby field removed the two women who had been riding on the rear seat of the sedan.

Pinned By Wheel

Uninjured, they were taken through the left rear door.

Sturmer, however, was pinned between the steering wheel of the car and right front door and it was necessary to attach a cable to the machine and to move it with a tractor before he could be reached. This required about 15 minutes. He was dead when taken from the automobile.

Meline said that the women thought that Sturmer may have fainted at the wheel of the car, causing him to lose control of the machine.

Shock to Family

The accident came as a shock to

members of the Holub family and to friends of the elderly shoe store proprietor and of Sturmer, a former Oroville resident.

Private services were held for Holub, however, as planned, and the body was sent to Sacramento for cremation.

Sturmer at one time was a resident of Cherokee. He was a cleanup man on Oroville dredges and also followed the same occupation in Hammonton, friends recalled. He was a stage driver at another time in his career, draving between Oroville and Susanville. In Chico he operated the elevator in the First National Bank Building.

Sturmer was a brother of Mrs. Mata Woolever, Mrs. Tillie Slissman, and Mrs. Frank Holub, all of Oroville, and of Mrs. Miller.

He explained that a piece of rope had caught fire in the cab and he had halted to extinguish the blaze.

He was released after questioning by District Attorney Otis D. Babcock. Deputy Sheriff Charles J. Ogle and Constable William Clarkson investigated and declared that Whelen apparently failed to see the truck and crashed against it without slowing down.

Whelan joined the prison staff in 1921 as a guard. A year later he was made sergeant of the first watch. Five years ago he was promoted to record clerk.

J. G. Nisbet Dies From Gun Wound

Former City Clerk
Passes Suddenly
This Afternoon

James Goldie Nisbet, 81, former city clerk and city judge and one time dredge superintendent, died in Oroville Curran hospital at 2:30 p. m. today from shock and hemorrhage caused by a wound received yesterday while he was cleaning an automatic pistol at his home.

Because of the seriousness of the wound, only slight hope had been held for Mr. Nisbet's recovery. The bullet, from a 380 calibre weapon, struck below the heart and emerged near the border of the lung, on the left side.

Mr. Nisbet, a pioneer Butte county resident, was widely known. Always interested in the county's history, he was active in preserving relics of the early days of its development. He frequently was consulted because of his knowledge of dredging activities and of historical facts.

Worked at Cherokee

He was born in Oregon City, March 12, 1857. His father had come to California in the gold rush days and had operated a pack train from Sacramento to Coloma before engaging in placer mining.

For a time young Nisbet worked at a mine in Browns Valley, where his father was superintendent.

Later he operated a monitor at the Cherokee mine. For two years he operated a hoist at the Kennedy mine in Amador county.

Afterward, for 15 years he was connected with the dredging industry, then at its height in Oroville. He worked on the old Oroville dredge before becoming superintendent of the Pennsylvania boat.

With W. H. James Mr. Nisbet purchased the Pennsylvania and operated it three years before taking up his residence on his ranch in Spring Valley, near Cherokee.

Wreckers To Lift Engine From River

Charboneau's Body Still Missing; Potee Rites Saturday; Westbound Train Escapes

Wrecking crews worked today on the difficult engineering problem of raising a 327,000-pound Mikado engine from the Feather River 300 feet below the Western Pacific roadbed near Pulga as the sequel to an early morning wreck that plunged two Oroville trainmen to their deaths Thursday.

A storm which sent a rock "as large as a roll top desk" into the path of the Scenic Limited, east-bound through the canyon, was blamed for the accident, which cost the lives of Halsey Sager (Harry) Potee, 53, veteran engineer, and L. C. Charboneau, 27, fireman.

Body Still Missing

Search was still being made today for Charboneau's body, believed to be buried in gravel and rock.

The search recalled the unsuccessful hunt made for the body of Stanley Andrews, lost when an engine plunged off the tracks near the Feather River highway bridge about eight years ago.

An engine and mail car were toppled toward the river, but one hundred fifty passengers aboard the train, en route from Oakland to Salt Lake City, escaped when a coupling parted and the cars remained on the rails. The cars were stopped automatically by air brakes when the engine and mail car separated. Many, asleep, were unaware of the accident. The engine was emerging from the east portal of Tunnel No. 9 at 2:30 a. m. when it struck the boulder, which had become loosened from the mountainside by the night's downpour and had fallen on the track. For a few seconds the engine, pushing the rock before it, shot ahead, tearing up 200 feet of ties and rail.

Plunges Into River

An instant later it began its awful plunge into the river.

It rolled over and over, stopped, with a mighty roar of steam, in the river. The lighter mail car slid down on one side down the mountain, stopping a few feet from the stream.

Surviving train crew members made their way with difficulty down the steep, rocky slope, using lanterns to search for possible survivors.

Mail Clerk Escapes

In the mail car, Earl P. Roberts, Sacramento, clerk, regained his feet and battered out a window on the upper side of the overturned car. Trainmen helped him through the opening. Almost miraculously, he had suffered only bruises. He remained with the mail until the track was cleared and the cargo and passengers continued eastward.

Potee's body, partly covered with rock, was picked up 30 feet from the river. His legs, arms and head had been crushed. Death was thought to have occurred instantly. He is believed to have been thrown from the engine as it rolled over.

The accident occurred about 2 1-2 miles this side of Pulga.

Potee Careful Engineer

Potee, regarded as one of the most careful engineers on the system, was reported to have been making 25 miles an hour at the time of the crash. He is thought to have applied the emergency brake as soon as the engine struck the rock.

Engineers said today that the rock was only 125 feet from the portal of the tunnel. The engineer and firemen, their vision temporarily obscured by smoke and steam as they rolled out of the bore, struck the rock before they were aware it was there, it is believed.

Forty-five minutes before this, westbound Passenger Train No. 1, had passed the same spot. But in those 45 minutes, somewhere on the mountain, the storm had started the slide.

Emory Brown, conductor of the trains walked two miles to Poe to telephone word of the accident to Oroville, and medical assistance was sent to the scene.

The ten cars of the train re-

mained in the tunnel after the crash until an engine arrived from Oroville and transferred the cars to Poe siding. Making up the train were two baggage cars, three Pullmans, one tourist sleeper, two chair cars, a day coach and an observation car. Train service was resumed about 3 p. m.

All available section hands from Oroville to Keddie were brought to the wreck scene. Sixty worked to re-lay the track, and two wreckers were summoned. On one of these, capable of lifting 200 tons, the rail-road will depend largely in raising the engine from the river. This wrecker, dispatched from Portola, is the largest on the system. A 100-ton wrecker also was sent from Oroville.

Father Seeks Son's Body

An inquest into the accident will be held, according to Sheriff Herbert Taylor, who visited the scene Thursday morning. However, date had not been fixed early this afternoon.

Charboneau had come to Oroville only three months ago. He lived at 1132 Bird street.

His father, roundhouse superintendent at Sparks, Nev., came here today to help search for his son's body.

Potee had been an engineer for the Western Pacific railroad since 1911. In these 26 years he had worked the entire time in the Feather river canyon. He was one of the best known engineers on the system, and was active in the Masonic lodge.

He was a native of East Liberty, Ohio, but had lived in California since 1911.

Funeral Rites Saturday


He was a member of East Liberty Lodge No. 247, Free and Accepted Masons, Portola chapter No. 321, Order of the Eastern Star, and Fountainhead Lodge No. 625 of the Knights of Pythias of East Liberty, Ohio.

Survivors are his wife, Mrs. Docey H. Potee; a sister, Mrs. G. I. Morse of Bellefontaine, Ohio; a brother, Joseph M. Potee of East Cleveland two nieces, Virginia and Margaret Morse of Bellefontaine.

Funeral services will be held at 2:30 p. m. Saturday at Hamilton and Riley's, with the Rev. H. C. Bever officiating. The body will be sent to Bellefontaine, Ohio, Sunday morning. It will be accompanied by Mrs. Potee and by O. H. Bryan of Oakland, general chairman of the Brotherhood of Locomotive Engineers on the Western Pacific system.

These two photographs, taken by a Mercury reporter on the spot. show the big Western Pacific engine on its side in the Feather River near Pulga and the mail car where it stopped in loose gravel after the engine early yesterday hit a rock and plunged 300 feet from the tracks to the stream killing two men. Note the turbulent waters of the river in the top picture. It is believed that Fireman Charboneau's body is in the water under the engine cab. In the lower picture the white dots mark the descent of the engine and mail car. The white cross is approximately where the body of Engineer Potce was found partly covered with rock. The minute size of the people seen standing on the tracks above the white dots give an idea of the extent of the drop to the river. The car at the tunnel is the baggage car which was derailed and left behind when the engine and mail car plunged down the steep bank. Considerable difficulty was experienced by the photographer in reaching the bottom of the canyon. He was forced to walk down the section of the old Hog Wallow road that led to this scene. Later it was discovered that cars could drive to the spot by another road.

Charles Feese, 71, of Hemstalk Court, died at the county infirmary at 4 p. m. Thursday.



BECAUSE his friends and fellow workers wanted to fulfill the last wish of Charles Feese, to keep his body from being buried in "potter's field," they all donated enough money to make up a burial fund. Feese died Thanksgiving Day at the county infirmary.

Feese, called Charlie or Shorty by all who knew him, was a familiar figure around Oroville, and could often be seen leaning on a lamp-post at the corner of Bird and Myers streets. He was well-known for his generosity, especially to children.

Friends said they never saw him give less than twenty-five cents to a chlid, and more often it was fifty cents or a dollar. One local girl received a five dollar bill on her birthday each year from the old man. He gave a five dollar bill to a bartender to start a bank account for a new arrival in the man's family. It was said that he spent \$15 in one night at a carnival treating the "kids."

Laborer All His Life

Feese had been a cement worker, hod carrier, and common laborer all his life. Because of poor health, he stopped working shortly after his seventy-first birthday, July 30. He was taken to the infirmary Thursday morning. He had been found in his cabin, unconscious, early that morning. He died at 4 p. m.

Funeral services were held at 2 p. m. Sunday at Hamilton and Riley's, with Rev. Herbert Brooke officiating. Milo Stram, accompanied by Mrs. Lula Hogan Wasley, sang one number. Casket bearers were Milo Stram, A. W. Phelps, A. C. Lineker, and C. C. Scott. Feese had worked for Stram for several years, and the other three were fellow employes.

Dean Of Butte Supervisors Passes

Final Rites Today For Henry White, Of Oregon City

Funeral services will be held at 2:00 o'clock this afternoon (Tuesday) from the Thomas Funeral Home at Oroville for Henry W. White, 68, Butte county supervisor from the fifth district for the past 23 years. Interment will take place in the Oregon City cemetery where his people are burried.

His death occurred Sunday morning and followed a long illness. Last March he moved to the hospital, where he could obtain care. Until the last month or two he attended board meetings.

Mr. White, who took pride in ploneer ancestry and in the fact that he had endured the hardships of an outdoor life on the range, was able only by his grim determination to attend board meetings in recent months, intimates said. Several times he had to be assisted to and from the supervisors' room.

Was Warm Friend, Bitter Enemy

He had the reputation of staunchly upholding those he considered his friends, but with being just as vigorous in openly fighting those he felt were his enemies.

Characteristic of him was his vehement denial from a hospital sick bed a few weeks ago of a report that he was to resign.

The supervisor was rational to within 20 minutes of his death. Then he lapsed into a sleep during which he died. His condition was fairly good until Saturday afternoon.

Pallbearers Named

Frank W. Boyle, former county purchasing agent, and long a close friend of the supervisor, said arrangements are in accordance with Mr. White's wishes, who even designated his pallbearers.

The supervisor said he didn't want a "lot of fuss" made over him, and would be satisfied to have a few of the men with whom he had ridden the range, and his friends from the court house and other intimates attend.

As a result of his wishes, casket bearers will be Martin Polk, county assessor and former clerk of the board of supervisors; Harry Hume, city manager of Chico, formerly county engineer; Charles Stearns, formerly assistant county engineer; and Charles Johnson, George Duensing and Elias Jones, cattlemen.

Survived By Cousins

Mr. White was a bachelor. His nearest relatives are cousins. They include Walter Williams and Miss Elizabeth Tyler of San Francisco, and other cousins in Michigan.

Space for courthouse employes and officials and for members of the Elks lodge will be reserved at the funeral home today.

Mr. White had been in public life since 1903 when he became a field deputy under A. E. Morton, county assessor.

He worked four or five months each year as a deputy. The remainder of the time he was principally engaged in the cattle business, in which he had "grown up," as he frequently expressed it.

Accustomed to the saddle, he covered his large territory as a deputy assessor by horseback. He had a pair of saddle bags in which he kept his books and records, his shaving outfit and a towel. He always wore a white shirt. He tried to arrange his schedule so that he could reach a boarding house, logging camp or a mine camp by nightfall. Sometimes, however, this was impossible, and on these occasions Mr. White and his horse were "put up" at a ranch house. Ranchers were always hospitable, he used to recall.

Always Remembered Faces

The future supervisor had an excellent memory for names and faces and could remember those he had met in his travels over his district.

One of the duties of field deputies in those days was to collect the poll tax. He also collected the personal property taxes and assessed real estate. The poll tax amounted to \$5 a year on all able bodied men except former soldiers, who paid only \$2.

There was a \$2 school tax, which even former service men and firemen had to pay, a \$2 county road tax and a \$1 hospital tax. The taxes had to be paid in cash, although in earlier years residents had been permitted to work out their road taxes on roads near their homes.

Elected to Board in 1914

In 1914 he became a candidate for the board of supervisors, and was elected at the primaries over three opponents.

Other members of the board at the time the Oregon City cattle man took office at the beginning of 1915 were C. E. Porter, Dave Evans, of Gridley, Bob Holmes of Chico and Tom Whipple of Wyandotte.

Worked For Highway

One project to which Mr. White dedicated his efforts, and in which he was greatly interested during his entire term of office was completion of what then was known as the North Fork highway.

At the time Mr. White came on the board each man appointed his own road foreman and had charge of the road equipment in his own district. Mr. White had two or three Fresno scrapers, a brokendown rock crusher and an old International high wheel harvester that supplied power for the rock crusher or for pumping water.

There was no county engineer, and the various supervisors handled road matters personally with such help as they obtained from Martin C. Polk, who was county surveyor from 1915 to 1919. Afterward under the charter, a county engineer was appointed by the board and the road system underwent a marked change.

Efficient Budget Man

During his long term on the board, Mr. White served many times as chairman. He was familiar with all county affairs, and was regarded as being particularly efficient in budget and financial matters. He was also much interested in road matters and often was made a member of road committees.

Mr. White was born in Oregon City, August 10, 1869.

Enters Cattle Business

At the age of 21, Mr. White entered in the cattle raising business. He added to his father's original ranch, of which he had become owner, and also obtained property on Table Mountain. He used the same brand—the figures 52—used by his father in 1852.

During the world war Mr. White was a member of the Council of National Defense with H. D. Gregory, then superior judge, the late Raymond A. Leonard, then district attorney, the late W. P. Lynch of Oregon City and the late Chas. Brown of Gridley.

The council selected the draft board and listened to numerous complaints and other matters.

Tom James Dies At Home In Cherokee

County; Local Banker And Cattleman

Tom James, 71, one of Butte county's best known citizens, died at his home in Cherokee early today following a week's illness. Death was caused by pneumonia. Mrs. May Thomas of Oroville, his only immediate relative, was at his bedside.

He was born in Cherokee, Feb. 28, 1866. He was the son of William James, for many years a member of the Butte county board of supervisors.

After graduation from the Cherokee school, Mr. James attended business college in San Francisco.

Joined Gold Rush

He worked for many years in the Rideout Smith National Bank, now the Bank of America.

He went to Alaska during the gold rush there. He made two trips to Alaska, and was employed by the Wild Goose Mining Co..

He became one of the largest land owners in Butte county and was in the cattle business virtually his entire lifetime.

His close friends knew him as a talented musician.

He had been a trustee of Cherokee school for 25 years.

He was one of the first members of the Masonic lodge in Oroville. His membership embraced Oroville Lodge No. 103, Franklin Chapter No. 22 and Oroville Commandery No. 5 of Knights Templar, and Islam Temple of the Mystic Shrine of San Francisco.

He is survived by his sister.

Charles William Bader, Jr. (C. W.), the eldest son of Christoph and Elizabeth Bader, was like his father, a blacksmith, miner and brewer. He owned the Magalia Hotel and Saloon until it burned to the ground in about 1894. Along with Frank Tate and others, he rebuilt the hotel in 1896. He served as Magalia's Postmaster from 1886 to 1890. On March 31, 1874, he married Mary Ellen Herbert in Cherokee, California. She was born in May 1855 in Swansea, Glamorgan, Wales and died October 18, 1902 in Magalia. They had eight children. After the passing of his first wife, C. W. Bader married again on August 8, 1910 in Chico, California to Emily Francis (Frasier) Robinson. She was born December 26, 1878 in Lynchburg, Virginia and died January 17, 1947 in Chico. They had one child. C. W. Bader's interest in gold mining never diminished. According to his grandson, Raymond Reeves/Fults, the Bader gold mines yielded some of the largest nuggets in the west. When he died in 1938 at the age of 86, his funeral was said to be the largest ever held in Butte County. The procession from Chico to the Cherokee Cemetery was estimated to be more than a mile long. On his tombstone is the simple inscription: "Asleep."

Dr. Leslie Freudenthal pronounced Wright dead, and, after performing an autopsy, said that the cause was a heart attack.

Wright was a native of Iowa and had lived here 15 years. Survivors include his wife, Mabel; a son Holbert, of Gridley; a step-daughter, Mrs. Mabel Buthero, of Los Angeles, and a brother, Claude Wright, of De Sabla, near Oroville. Funeral services will be held here at 10 a.m. Thursday.

Oroville Man Killed Under S. P. Engine

F. R. Knapp Was
Driving Road Roller Across Tracks

F. R. Knapp, 44, Oroville, was mangled to death late Tuesday afternoon north of Chico when he drove a road roller into the path of a Southern Pacific freight engine.

The accident happened at the Bennett Road crossing where a county crew was working on the road. Pearl Kesterson of Chico, foreman of Knapp's crew, saw the crash.

Knapp had crossed the tracks with his roller and was returning, keeping his eyes on the road, when the engineer whistled for the crossing. Because of the noise of his roller, Knapp failed to hear the engine and kept on moving toward the tracks.

The big mallet engine, speeding at 40 miles an hour, hit the machine on the right rear wheel and carried it 100 feet down the track. Knapp's managled body was picked up 250 feet from the crossing between the tracks.

Kesterson said that immediately after the crash, the gasoline tank of the roller exploded, and set the machine ablaze.

Fear that the oil tank car in the rear of the engine might explode was felt, as the blazing wreckage sent flames curling around it and high into the air. The train was moved to prevent the tanker catching fire, but the heat scorched the side of a refrigerator car.

Finally trainmen were forced to move the 60 car train out of reach of the blaze. Dry grass on the right of way was burned off by the fire.

The train was No. 497, southbound, and was immediately followed by the passenger which was routed on a siding and was delayed only a few minutes.

E. G. Beyers, Chico agent for the Southern Pacific could not give the names of the engineer and fireman on the train.

Knapp, who had been with the road department for five years, lives on the Chico road out of Oro-ville.

The body was taken to Chico and transferred to the Hamilton and Riley funeral parlors in Oroville.

Deputy Coroner H. C. Bicknell said an inquest will be held.

Survivors include the widow, Mrs. Ethel Knapp; a daughter, Ramana Jane, 6; three sons, Robert, 1, Lawrence B. Knapp, 19, and Donald H. Knapp, 16; a stepson, Clifford Leo Lentz, 16, all living on Chico road. He is also survived by his mother, Mrs. Rose B. Knapp and a brother, Roy Knapp, both of Webber, Kans.

Funeral services will be held at 4 p. m. Saturday at Hamilton and Riley's, with Rev. Herbert Brooke officiating. Interment will be in Cherokee cemetery.

Ernest Hesbol, Clear Creek Rancher, Dies

Ernest Wesbot, 75, Clear Crock cattle man and orange grower, died in a Chico hospital at 1:20 p. m. Sunday following an operation. His health began failing in recent months, and he became seriously ill about a week ago.

Mr. Hesbel came to the Oroville district about 54 years ugo. He was one of the best known older residents of the urfa.

He was born Sept. 8, 1863, in Norway, but left there at the age of 20 to come to California.

WORKED AT BIG BEND

He first worked on the ranch of Bob Moore and later on the Hefner Banch. Later he was one of the men who helped construct the Big Bend tunnel. After working two years on the tunnel, he was employed in hallding the rock wall on the Feather river several miles above Oroville, created to turn the river from its normal channel so the stream bed could be mined.

Major McLaughlin, manager of the Banner mine, was in charge of the underlaking. After two years' work on the wall, Mr. Hesbol became an employe of the Banner nine. During an employment of approximately ten years he worked underground and also operated the hoist.

RAISED PRIZE CROPS

He had sold 30 acres of land on the Feather river, below Pacific Heights, which he had purchased while working on the McLaughlin dam, and had moved to Panuer inite.

About 34 years ago the family moved to Clear Creek.

Mr. Heshol became well known for the watermelons and high quality garden truck grown on his ranch. In 1909 he won first prize at the state fair for yellow corn grown in upper California.

He used to drive to Oroville with loads of melons, some as large as 60 pounds. Westwood and Ward, grocers, handled much of his fruit. Pirst melons, Mr. Hesbol recalled, used to bring \$3 a dozen. Later in the fall the price often dropped to \$1 a dozen.

On his ranch are two of the oldest orange trees in northern California.

He planted an orange grove, selling the fruit locally.
