### Illness Takes Alma Jelmyer


Miss Alma Elizabeth Jelmyer, 22, died at 10 p. m. Saturday at her home, 1809 Pine street, after an illness of several months.


Mrs. Whisler was a member of the Methodist church in Chico.

### Body Of Oroville Woman Is Found In Burning Home

OROVILLE (Butte Co.), May 12. The body of Miss Wanda Wilson, 41, club worker and former newspaperwoman, was taken from her burning home at 12:15 A. M. today.

Fire Chief A. F. Kessler and Sheriff-Coroner W. H. Forward were pressing an investigation into unexplained circumstances in connection with the fire. The officials reported Miss Wilson's body, the clothing practically burned off, was found on the floor of the kitchen. All gas burners of the stove, including the oven, were burning.

Explosions Were Heard Robert Cole, a neighbor and an employe of the Western Pacific Railroad, told Kessler he walked by the two story Wilson home a few minutes before the fire was discovered. At that time, he reported.

the house was in darkness.

He said he heard a muffled explosion followed by two lighter blasts in succession and flames seemed to shoot out from several parts of the house. He turned in the alarm, ran to the burning house and found the doors locked.

Was Mass Of Flames

The firemen said the interior was a mass of flames and the fire seemed to have started in several places at the same time.

The body of Miss Wilson's pet dog also was found in the kitchen. Neighbors heard her call the dog

It was not determined whether Miss Wilson's death was caused by asphyxiation or by burning. body was removed to Hamilton & Riley's. An autopsy was to be per-

formed later today.

Miss Wilson lived alone in the home since her brother, Alex E. Oroville newspaperman, Wilson. mining man and real estate operator, was commissioned a major in the army several months ago. A housekeeper stayed there part of the time but she left Monday for Belden, Plumas County.

Brother Is General

Other brothers, Brigadier General Arthur R. Wilson, United States Army, and William Wilson, principal of the Grass Valley Union High School, have been absent from the family home for a number of years. The house, at 2585 Brown Street, was erected by her father, the late Alex M. Wilson, widely known mining man. Both Miss Wilson's father and mother died in recent years. Friends say she appeared depressed since the death of an aunt, Mrs. Sarah E. Camp, widow of A. E. Camp, early day school teacher, last April 22nd.

Miss Wilson attended the Chico State Normal School, now Chico State College. She was active in civic and club work and did considerable historical research, especially of early Butte County, for the Native Daughters of the Golden At one time she was The Bee's news correspondent here and had been employed since by local

papers and in offices.

### Murder Suspected In Oroville Death

OROVILLE, May 12. (IP) — Miss Wanda Wilson, about 40, one of the last members of a pioneer northern California mining family, was burned to death today when her home was destroyed by fire.

She was the sister of Brig. Gen. Arthur Wilson, now in North Africa; Maj. Alex E. Wilson, in England, and William Wilson, vice principal of the Grass Valley high school. Her parents were the late Mr. and Mrs. Alex Wilson.

Robert Cole, a Western Pacific trainman, told authorities he passed by the house only a few minutes before there was a muffied explosion, and the two-story house seemed to be afire all at once. The body of Miss Wilson was found in the kitchen and gas jets had opened. Authorities checked the possibility of suicide or foul play, since the house contained antiques and valuable silverware. of which was lost in the most flames.

### Inquest Is Set In Fire Death

OROVILLE (Butte Co.), May 13. An inquest will be held tonight at 8 o'clock in the Thomas Funeral Home in the death of Miss Wanda Wilson, 41, whose body was found early yesterday in the kitchen of her burning home.

Firemen said they found the doors locked, all gas burners on the kitchen stove turned on and chinks of the kitchen door stuffed with paper.

Funeral services were scheduled for this afternoon in Hamilton & Riley's Chapel with Rev. F. E. Carlson of the First Congregational Church officiating. Burlal was to follow in the Cherokee Cemetery.

Miss Wilson was an officer in the First Congregational Church and in the Ora Vista Improvement Club and was a worker in the Native Daughters of the Golden West and Womens Relief Corps activities.

## Asphyxiation Is Listed As Cause Of Butte Death

OROVILLE (Butte Co.), May 14. An open verdict that Miss Wanda Wilson, 43 year old church and club worker and former newspaperwoman, died of asphyxiation was returned by a coroner's jury here last night, although both Sheriff-Coroner W. H. Forward and Police-Fire Chief A. F. Kessler expressed the opinion the death was a suicide.

The charred body of Miss Wilson was found here in the home she occupied alone, after the structure flames. burst into following muffled explosion soon after midnight on the morning of May 12th. Indications were that the woman had committed suicide by inhalation of illuminating gas and that the resultant explosion and fire was caused when the gas was igfrom some undetermined nited cause.

#### Prepared For Death

Evidence obtained by the investigating officers indicated Miss Wilson had prepared carefully for her death. In a discussion of the world situation with a neighbor on the afternoon of last Tuesday Miss Wilson expressed the opinion, "Why does a person want to live in such a cruel world?"

The officers learned that on that date she returned to the Congregational Church, of which she was an officer, various books and documents she had kept in her home. She also returned to the local cemetery association the books and records that had been in her keeping. She was the secretary of the association. It was learned she had removed various valuables from her home and placed them in a bank for safekeeping.

#### Dog Accompanied Mistress

Testimony adduced at the inquest indicated Miss Wilson had decided to be accompanied in death by her faithful companion, her shepherd dcg. The animal's body was beside that of its mistress. Neighbors testified to having heard her calling the animal into her home at about 10:15 o'clock Tuesday night.

The doors leading from the kitchen of the dwelling had been chinked with pieces of newspaper and all of the jets on the kitchen stove had been turned on.


## Death Takes Old Teamster

His brother, James Goodwin, started Tempe's first streetcar service, consisting of a small car drawn by a horse or a mule—whichever was available. The line traversed the town's downtown and main residential districts. The two brothers finally had to abandon the line after it became for a time a self-service affair on which the few remaining passengers did their own driving.

Mr. Goodwin attended Tempe public schools and was graduated from the old Tempe Normal School, which is now Arizona State Teachers College. He was a star football player for the school.

For many years he served as secretary on the college's board of education. Goodwin stadium there was named for him.

Early in his business career ne pedaled a railroad track car from Phoenix to Mesa, delivering the now defunct Phoenix Herald. Later he was a carrier for the Arizona Republic in Tempe and Mesa.

He said that Miller, who had said he was ill, had promised to remain only until another caretaker could be engaged.

An Indian boy, alarmed by finding no footprints from Miller's cabin or any to the mail depot, discovered the body, Phelps said.

Phelps knew nothing of Miller's antecedents.





## Early Day Store Keeper In Butte Foothills Is Dead

OROVILLE (Butte Co.), Dec. 4.—David Louis Vintin, 76 year old storekeeper, mining man and leading citizen of the onetime flourishing community of Cherokee, died yesterday morning in the Oroville Curran Hospital here, where he had been taken after the second of two strokes.

His general store was a classic in the merchandising techniques of an almost forgotten day, lighted by oil lanterns and crammed, with clothing and other articles, many of which were bought from drummers who made their rounds in buggies.

Tucked into the shelves in ever changing hiding places, were scores of Cherokee diamonds, which Vintin once protected from thieves who gave him a severe beating trying to make him divulge his cache.

He was one of five children of Mr. and Mrs. Thomas L. Vintin and was born in Cherokee in 1867. He was a bachelor and is survived by his sister, Miss Ruth Vintin, who was taken to Oakland to live with relatives after her brother's first stroke October 25th.

Funeral services tentatively have been set for Thursday in Hamilton & Riley's here. Burial will be made in the Vintin family mausoleum in the Cherokee Cemetery.

### Murder Charge In Killing Of James F. Nisbet

Accuse Joseph Shallet
In Shooting At Pulga

The district attorney's office this afternoon filed a murder complaint against Joseph Shallet, 42, of Pulga for the shooting Saturday night of James Filter Nisbet, 32, of Oroville.

Shot seven times with bullets from a 380-calibre pistol, Nisbet, in a statement made three hours before he died, accused Shallet of firing the gun.

Shallet was arrested by Undersheriff Warren Bain, Deputy Sheriff Earl Jester and Clarence Hayes, special officer, at the A. R. Scott residence in Pulga. A fully loaded 380 calibre pistol was in Shallet's possession. This calibre is between a 32 and a 38.

FIND-HIM ON FLOOR

Notified by telephone Saturday about 11 p. m. that there had been a shooting at the residence of Mrs. Ann Reynolds of Pulga, authorities on arrival there, found Nisbet, his body bullet-riddled, on the floor near the back door of the house.

Nisbet was still conscious. "I'm shot all to hell," he said. There were five empty cartridges on the floor, near Nisbet and three lead slugs that had passed through his body. Three of the shots had hit Nisbet in the stomach. Two struck him in the left arm and two in the chest.

Dispatched from Oroville at 11:30 p. m., the community ambulance had Nisbet at the Oroville Curran hospital shortly after 1 a. m. Doctors worked steadily for four hours in an attempt to save his life.

HAD BEEN NO ARGUMENT

In his statement made at the hospital Nisbet said he and Shallet had been good friends and that there had been no argument between them.

According to Harry Gray, special investigator from the district attorney's office, Shallet and Mrs. Scott on their return from a shopping trip in Oroville, were told that Nisbet was drunk and creating a disturbance at the Reynolds home. Gray said Shellet told him he went home to get his gun before going to the Reynolds home. He was accompanied there by Ernest Reynolds, 14, one of five children in the family. Mrs. Reynolds was at the Scott home.

"POURED IT TO HIM"

Nisbet made his appearance while Shallet was getting the children ready to leave, Shallet told Gray. He said Nisbet made a dive for him and seemed to be reaching for something, "so I poured it to him."

Nisbet wes an employe of the Western. Pacific Railroad. Shallet was unemployed but had been doing bridge work for the railroad according to the sheriff's office. Shallet has resided in Pulga for the past 18 months. He previously lived in Sacramento.

Nisbet was the son of the late Roy Nisbet of Oroville and Mrs. Agnes Nisbet of San Francisco, an employe of the California Department of Cosmetology.
