Butte Deputy Sheriff Is Held On Killing Count

OROVILLE (Butte Co.), March 25.—Meril Metcalf, 45, special agent employed by the T. E. Connelly Construction Company and a Butte County deputy sheriff, is held in jail here on a charge of murder.

The complaint was signed yesterday by Mrs. Florence Schwartz of Grass Valley, widow of George Elmer Schwartz, 42, who died Monday after an altercation with Metcalf near Pulga on the Feather River.

District Attorney R. A. Leonard said the arrest was ordered after he had interviewed a number of workmen who said they saw Metcalf strike Schwartz with his fists. Schwartz died shortly after and an autopsy showed death was due to a cerebral hemorrhage.

Men Complain

The fight and the subsequent death on Monday had not been regarded as a criminal matter by the authorities until Mrs. Schwartz and a dozen or more men on the job came here to complain to Leonard and Sheriff W. H. Forward. Metcalf was arrested yesterday afternoon.

Leonard said witnesses failed to substantiate Metcalf's official story, in which he admitted striking Schwartz once after Schwartz had grabbed his shirt.

Leonard said:

"The other men told me Metcalf struck Schwartz on three occasions, all that afternoon."

Inquest Planned

Sheriff Forward, who also is coroner, said he will hold an inquest, but has set no date.

Schwartz was an employe of the Arundel-Dixon Company, which has a contract on the Pacific Gas and Electric Company's dam project in the Plumas County section of the Feather River Canyon.

Grass Valley sources said Schwartz was captain of the Washington State college football team which played Alabama in the Rose Bowl on January 1, 1931, and later played professional football with Pittsburgh.

Schwartz's body has been sent to Grass Valley by the Sanford Funeral Home. Besides his wife, Schwartz is survived by a son, Lyle; a daughter, Nancy; a sister. Mrs. Kent Walker; a brother, Ernest Ross, and his mother, all of Nevada City.

Famous Indian Known to Many Dies at Age 80

Full-Blooded Concow, He Lived His Life in Woods and Mountains

DIXIE JOHNSON, famed tracker who could read the footprints in the woods as others can read print, died at midnight last night at the home of Thomas Melvin in Paradise. He was 80.

Mr. Johnon, a full-blooded Concow Indian, has lived his entire life in the mountains surrounding Oroville and Paradise, and has long been known as the nemisis of holdup men who start out on foot through the forests.

During the past 30 years Mr. Johnson was not often in the lime-

light as he was before then, when he helped solve some of the county's most puzzling crimes.

He has been living at Intake near Las Plumas where he worked a mining claim. His last act was one of helpfulness to a friend. Last Monday Dixie traveled to Paradise to help Melvin, a friend of long standing, to do assessment work on Melvin's mining claim in rugged Big Butte creek canyon.

Apparently his tired heart gave out last night.

It was in 1915 that Mr. Johnson performed a feat that made him famous when he tracked down two payroll robbers near Stirling City after more than 500 men had wallowed throughout the woods in the search.

TWO MEN robbed DM's camp No. 1, of \$2800 in August of that year. Officers and volunteers spent three fruitless days in the area searching for the robbers before Mr. Johnson was called.

For eight days Mr. Johnson and Bill Peachy, a one-time constable, searched the woods until one day Dixle spotted tracks leading from a highway to a clump of bushes. It was as though a man had stepped off the road seeking cover of the brush. It was this track that led Mr. Johnson and Peahey to the spot where the robbers had fled following the robbery. Part way up a long hill, the robbers had resorted to a log chute but Mr. Johnson found where they had stepped on a log, followed the trail to the robbers hangout.

Odd sequel to the story was that the robbers, when they realized they weer being tracked, hid their firearms and the money, but later, after their arrest, it was discovered that a transient had found the can in which the money had been deposited and had made away with it.

DIXIE IS survived by his wife Maude Johnson who lives in Pulga; a son Elmer Johnson of Pulga and a grandson Edward Johnson of Brush Creek.

FAMOUS INDIAN TRACKER DIES

Dixie Johnson, Indian tracker who used to pursue outlaws through the woods and hills, last week followed the invisible footprints of death into a darker valley. He died here, apparently of a heart condition, at the home of a friend, Thomas Melvin, late Wednesday night. He was over 80 years old.

Johnson was born and went to school in Yankee Hill, and spent his entire life in this region. He was a full-blooded Concow Indian, and had the Indian's skill and knowledge of the woods. In past years he was employed by the sheriff's office to track down holdup men who disappeared into the hills.

His most famous exploit was the tracking down of two payroll robbers near Stirling City in 1915. More than 500 officers and volunteers had searched the forests for two days before Johnson was called upon. He and a constable searched for eight days until Dixie spotted tracks leading from a highway to a clump of bushes: They followed this track. Part way up a long hill, the robbers had resorted to a log chute, but Johnson found where they had stepped on a log and followed the trail to the robbers' hangout.

A few years ago, Dixie was employed during the fishing and hunting seasons by the North Fork of the American River Association, a Sacramento and San Francisco sportsman's group which has land holdings of 10,000 acres at Soda Springs, in the Sierras near Truckee. Dixie's job was to guide fishing and hunting parties of the members. Through this employment he became acquainted with and was a frequent visitor in the homes of many of the state's most prominent sportsmen in Sacramento and San Francisco.

In recent years Dixie has been living at Intake, near Las Plumas, where he worked a mining claim. He drove over to Paradise from there the Monday preceding his death in order to do assessment work on Melvin's mining claim in Big Butte Creek canyon. He had had a heart ailment for some time, and became ill shortly after he arrived here.

He is survived by his wife, Maude Johnson, who lives at Mayaro, near Pulga; a son, Elmer Johnson of Pulga; a grandson, Edward Johnson of Berry Creek, and two great-grandchildren.

The funeral was held at 2 o'clock Monday, with Rev. W. S. Woodhull of Paradise conducting graveside services at the Yankee Hill Cemetery.

Mrs. Lois Zirkle Killed When Car Goes off Road on Curve

Mrs. Lois Anita Zirkle was killed late Sunday night when her car plunged over the embankment on a sharp downhill curve on the newly constructed portion of Pearson Road between the Clark and Pentz Roads. Her body was found lying beside the battered sedan at the bottom of the steep gully about 10 o'clock Monday morning.

Mrs. Zirkle, a nurse's aide at the county hospital, was on her way to work in Oroville when her car went off the road. Her husband, Roy Zirkle, said she left her home in Paradise at 11:10 p.m. to go to work on the midnight shift. The accident must have occurred shortly thereafter, as she never arrived at the hospital.

The tracks showed that the car had crossed the road after failing to make the right-hand turn, and gone along the left edge of the road before sliding over the embankment. It had apparently turned over completely, as the top and left door were caved in, but the car was standing upright.

Mrs. Zirkle's body and the wrecked car were found by C. Bray of Chico, a Pacific Telephone and Telegraph Company employe. He said that the car lights were still burning then. He notified authorities, and Deputy Sheriff Leslie Thomas, Constable R. L. Easley and Paul Gaukel, deputy coroner, went to the scene. Later Deputy Sheriff R. L. Easley, Jr., and Frank Rhodes, chief deputy coroner, came out from Oroville to investigate the tragedy.

An autopsy performed by Dr. Garth Rustin showed that death was due to internal injuries, and it was assumed that she had been killed instantly.

Officers said Mrs. Zirkle might have been blinded by dust from another car on the unpaved road.

Ray Forman of the Ridge Motor Service, who towed the car away later, said that he had towed away another car about a month ago which had gone off the road on the same curve. In that case the woman driving it had lost control when she put on the brakes and the car had chattered over the loose gravel.

Mrs. S. A. Kuhre of Paradise said that she had driven her husband to work over the road about 6 o'clock that morning and on her return had noticed the marks running off the road when she passed the spot, but had not seen the wrecked car below.

Mrs. Zirkle was born in Kansas April 19, 1912, and had lived in Paradise for about eight years. She is survived, in addition to her husband, by three children, Cynthia Louise, Martha Eileen and Daniel Arthur; her father, Orlo Jones of Paradise; her mother. Mrs. Edith Jones of Paradise: two brothers, Orlo and Arthur Jones of San Francisco, and her grandfather, Marion E. Lanham of Kansas City, Mo. Other surviving relatives are Marguerite LeFever, Verda Lauson, Carl, Roy and Bill Zirkle: Francis and Leona Jones.

Famed Riverman Nevills, Wife Die in Air Crash

MEXICAN HAT, San Juan County, Sept. 19—Norman Nevills, 41, famous "river rat" who had emerged unscathed from battles with roaring rapids of the Colorado and many other adventuresome rivers in the west, and his wife, Mrs. Doris Nevills, were killed here early Monday when their plane crashed during takeoff.

A veteran with 16 years river experience behind him, Nevills apparently had no chance to exercise the "quick thinking" which had delivered him safely in many a dangerous moment during his career as a riverman.

The light plane crashed as it was taking off from the private landing strip which Nevills had built near his desert home here. It crashed against the steep wall of a wash just beyond the end of the strip and in the fire which followed the bodies of Nevills and his wife were burned beyond recognition.

Witnessing the crash was Mrs. Mae Doris Nevills, mother of the riverman, and the couple's 8-year-old daughter, Sandra Jane. They were standing on the runway after bidding good-by to Norman and his wife, who were going to Grand Junction, Colo.

Appeals for Help

Ray Lyman, Blanding rancher who was a personal friend of the riverman, said the elder Mrs. Nevills sought assistance from C. R. Cochran, an oil crew foreman, after she saw the plane crash. Cochran took her to Blanding after he had climbed down the wash to inspect the flaming wreckage and determined that the victims were dead.

Members of a party of Nevilla friends who flew to Mexican Hat Monday morning after learning of the crash reported that the plane apparently developed motor trouble during the takeoff.

Flying for Landing

They said the plane took off in a southerly direction, and had turned around and was flying north apparently for a landing when it crashed into the face of the wash. The wash is located at the southern end of the landing strip, they said.

He had lived here since 1933, and during the past 16 years had logged an estimated 20,000 miles of travel on western America's most treacherous rivers—the Colorado. San Juan, Green and Idaho's famous "River of No Return," the Salmon.

A flier with several thousand hours in the air to his credit, he utilized the airplane as the only feasible means of quick transportation between his isolated desert home and the outside world.
