## Pioneer Doctor Dies at Age of 90

Dr. W. H. Snook, 90, whose service as a physician in Central Oregon dated to the horse and buggy days and his residence in the Madras area to distant 1903, died in Bend this morning at the home of his daughter, Mrs. Don S. Denning. Dr. Snook, who retired six years ago, had been ailing for some time, the result of infirmities of advancing age.

A native of Fairfield, Iowa, where he was born on Feb. 12, 1863, Dr. Snook received his education in Fairfield and at the College of Physicians and Surgeons, now the University of Iowa. Following his graduation from college in 1886, he practiced medicine in Fairfield for several years, then came west in 1899, and was married that year in Portland to Estelle Vinton, member of a pioneer Sherman county family. He is survived by his wife and two children, Mrs. Denning and M. C. Snook, of Portland. Also surviving are four grandchildren, Dr. William Snook, McChord Field, Wash.; Lt. James Snook, now in Japan; Don Denning, University of Oregon student, and Marvin Mix, student at O. S. C.

### In Area 50 Years

Following their marriage, Dr. and Mrs. Snook lived for a few years in Pacific Grove, Calif. It was in 1903, year Bend appeared on the map of Oregon, that Dr. Snook moved to the newly-settled Madras country, where he filed on a homestead and entered the practice of medicine in Madras. He practiced there until his retirement. A contemporary of early days was Dr. U. C. Coe, pioneer Bend physician. For many years, Dr. Snook served practically all of north-central Oregon, with trips made by horse and buggy until 1910, year he purchased his first automobile.

Dr. and Mrs. Snook continued to make their home in Madras through the years. For the past 17 months, during which time Dr. Snook was ill, they made their home in Bend with their daughter.

## William Bidsworth Dies This Morning At Sister's Home

William Bidsworth, lifetime Butte County resident, died this morning at the Chico home of his sister, Mrs. Emma Corbett.

He was born near Pentz, Aug. 3, 1873. His parents were pioneer residents of this county. His mother, the late Mrs. A. Thankful Carson, was the sole survivor of the Lewis children who were captured by the Mill Creek Indians in 1863 at what is now the Williams Road near Pentz.

Mrs. Carson came to Butte County from Missouri by ox-team in 1854, when she was four months old. In 1915 Mrs. Carson, nee Lewis, published a short history, "A True Story of the Capture of the Sam Lewis Children."

Mr. Bidsworth first attended the old Bruce School on Bruce Lane, east of Chico and later, Mrs. White's School in Chico. He operated two large cattle ranches, one on Butte Creek near the old covered bridge and the other near Paradise. He also worked at times for the forest service, his knowledge of the terrain of northern and eastern Butte County, proving valuable in trail blazing and surveying in the mountains.

For the past two years he made his home with his sister in Chico. He was not married. He was a member of the Chico Lodge of Moose.

Mr. Bidsworth is survived by Mrs. Corbett; and four nephews, Davis Brown and James Peters, both of Butte Creek, Joe Peters, of Chico, and Willis Burke, of Nord.

Funeral services will be held in Huddleston Funeral Chapel Saturday afternoon at 1:30 o'clock.

Interment will be in the family plot in Clear Creek Cemetery.

## Wm. Bidsworth, Descendant of Pioneers, Dies

William Bidsworth, descendant of a pioneer family of this area, died Wednesday morning in Chico in the home of his sister, Mrs. Emma Corbett.

He was born near Little Dry creek on August 3, 1873. Until about two years ago he lived at his ranch on the Honey Run road just below the covered bridge.

Bidsworth was the son of Thankful Lewis Carson, who was famous as the sole survivor of a kidnapping in 1863 by hostile Indians just a few miles from Paradise.

In an interview for the Post's "You Meet Them on the Ridge" series, Bidsworth told the story of his mother's and her two brothers' abduction. At that time he was still living in the home on Big Butte creek where his mother died in 1933.

The kidnapping occurred as the three Lewis children were returning from the Clear Creek school on the Cherokee road. Jimmy Lewis was then 11, his brother Johnny was 6, and Thankful was 9.

As they stopped to drink in Little Dry creek, about a half mile from their home, they were accosted by several Mill Creek Indians and one from the Bidwell rancheria in Chico. Jimmy was shot and killed at once as he was bending down to drink.

Johnny and Thankful were taken off through the woods through canyons and across Neal road, and in the morning Johnny was killed also. Thankful, however, managed to escape, after many harrowing hours, near Big Chico creek. The settlers banded together to avenge the murders and many Indians were killed.

Bidsworth knew Paradise when it was a wilderness of pines. In later years when he came to visit, he marveled at its growth and called himself "a stranger in his own land." He dealt in cattle, was a woodsman and a miner most of his life.

Funeral services will be tomorrow afternoon in Chico.

During the latter years her husband, now retired, was a dredge master.

Mrs. Payton formerly held office in the Rebekah Lodge of Placerville, El Dorado County. She lived in Sacramento 31 years.

Also surviving are her sons, Forrest E. and H. L. Payton, both of Sacramento; daughters, Louise Bolln of San Francisco and Isabel McCloud of Stockton, San Joaquin County, a sister, Leona Jones of Oregon, and eight grandchildren.

Later, a second collection sent Mr. and Mrs. Adams to San Francisco to be with Jimmy for a while. He seemed to be rallying from the disease and his parents returned to Pentz, the

father to take a job with the Diamond Match Company and his older sons, Earl, 20, and Barney, 18, to go to work for the Pacific Gas and Electric Company.

In San Francisco, physicians tried an experimental drug to halt the ravages of the leukemia but held out little hope from the outset.

So now the money raised in the Pentz Paradise Oroville area will pay for all that now can be done for Jimmy—his funeral.
