Pioneer Resident Of Pentz, Bessie Blum, Dies at 81

PARADISE (E-R) — Death claimed Mrs. Bessie Lyte Blum, 81, of Pentz, Saturday morning, at a Paradise Nursing home where she succumbed to a stroke after recuperating from recent surgery and a broken hip sustained in a fall last month.

Mrs. Blum lived for 65 years at the family ranch and mine at Durbin Canyon along Dry Creek and participated in many of the colorful pioneer events of the historic area.

She was born in Ely, Vt. March 10, 1877, and came to Pentz as a child. She attended Pentz School, was married and raised her children there. Her late husband, Edward Blum, who preceded her in death in 1932, was born in Pentz near where Kunkle Reservoir is located. His mother was shot in the thigh by Indians while working in her garden, four months before Blum was born, and she died from effects of the gunshot the day after his birth.

Mrs. Blum's family was engaged

in mining, and her late husband owned and operated the Blum Mine in Dry Creek Canyon until his death.

When the small Pentz School celebrated its centennial year last summer. Mrs. Blum wrote a history of the area for its pupils. In it she related details about the active lumber industry there in the late 1800s, when the Flea Valley Lumber Co. had its big mill there and shipped lumber by flume. She was a young girl when the settlement boasted two hotels, restaurants, a saloon and meeting hall.

Her history also recalled vast fruit and vineyard developments which were wiped out in the grasshopper plague of 1894.

A highlight of her long lifetime in Pentz was the visit in 1881 of President and Mrs Hayes, who, with Gen. John Bidwell and Mrs. Bidwell, visited the four hydraulic mines operating in the area, panned gold, and were feted at a dinner in Pentz at which miners presented Mrs. Hayes with a large Cherokee diamond.

She lived to see the area change from a roaring lumber and mining town to a grasshopper-evastated foothill section and later, with no relic of the town remaining, to witness the area regain some of its economy through cattle, hog and sheep raising and hay crops.

Survivors are two sons, Alfred, of Oroville, and Robert of Pentz, and one grandson.

Funeral services will be held at the Paradise Chapel of the Pines Wednesday at 11 a.m.

Burial will be in the family plot at Cherokee Cemetery.

Ivan A. Jones Cattleman Of Cherokee, Dies

Ivan Albert Jones, 65, a lifetime resident of Butte county, died Friday in a local hospital after an extended illness.

Mr. Jones died on the 65th anniversary of the day he was born in Oregon City. His grandfather settled in that area more than 100 years ago and often claimed that he was the first man to clear a portion of Crane Valley for a cattle ranch. His father, the late Elias Jones, ran a cattle ranch on Table Mountain.

Mr. Jones operated a cattle ranch for many years near Chero-kee and was engaged in that occupation at the time of his death. He also followed construction work for many years before retiring from the State Department of Highways a year ago. Until he became ill, he devoted most of his time to his cattle ranch.

Mr. Jones was a member and past master of Table Mountain Lodge No. 124, F&AM and was active until recently in lodge affairs. He headed the organization in 1934. Mr. Jones was also a member of the Butte County Cattlemen's Association.

He leaves his wife, Mable, Oroville; two sons, Wesley W. and Donald E., both of Redding; a daughter, Mrs. Amadee Hendershot, Oroville, and three sisters, Mrs. T. R. Cole, and Mrs. Maude Painter, of Oakland, and Mrs. Isabell Pratt, of San Jose. There are also eight grandchildren.

Old Indian Woman Takes History Into Her Grave

Belle Rau was buried at Cherokee Cemetery Monday, and into the grave with her went a chapter of Butte County history.

Belle was a simple Indian woman, 92 years of age - according to the best available records - and without family or relatives. A brief notice by the Sanford Funcral Home marked her passing, and only a handful of mourners attended the services. Her funeral was a curious mixture of the modern and the ancient. The Rev. Mr. Robert John, of First Christian Church, pronounced the traditional funeral pasages of the church as her body was interred.

And into her coffin were placed the strings of beads and the woven baskets she had fashioned with her own hands many years ago, even before Benjamin Harrison became President of the United States.

Ancient Customs

Those, according to the ancient customs of her tribe, were to be her gifts to the Great Spirit when she arrives at the Happy Hunting Ground. Into her coffin also, by ancient custom, was placed a bottle of clear spring water, to assuage her thirst during her journey.

To all intents and purposes, the story of Belle Rau was at an end. She had lived, she had died and she was buried. She had become a "vital statistic".

But the story of Belle Rau lies not in what or who she was but rather in the era that her life encompassed. For much of the history of Butte County, and even California, was written during her lifetime. RAU, Belle Oroville Mercury 5-5-1959 page 2 of 2

The records show that Belle was born on December 21, 1866, at Cherokee, very near the spot where she died. According to lod-time residents of the area, most of whom were children when Belle was approaching middle age, she could have been many years older than the record states.

Date Chosen At Random

Antone Rau, her third husband, told a friend 20 years ago that Belle was past 80 at that time. Her birth date, he said, was chosen at random in order that her name might be placed on the rolls of the Indian Office records and thereby she would be eligible to receive a pension.

She was considered an elderly woman when she cooked at a construction camp in the Feather River Canyon during the bawdy days, when the Western Pacific Railroad was being built past Oroville and toward the great desert of Nevada.

She watched the first of the great iron monsters force its way over the land that had been her unfenced and unscarred playground during the first decade following the Civil War.

She was said to be the last mem-

ber of the Bloomer Hill California Indians, and her second husband, Fred Johnson, was a chief of the tribe before his death more than 30 years ago. Before his death he served as a delegate at a conference on Indian affairs held in San Francisco.

Married 3 Times

In all, Belle was married three times, the first time to Denny Williams long before the turn of the century. All of her marriages were performed according to the customs of her tribe. Her last husband, Antone, died a few years ago at Cherokee.

After the construction of the railroad, Belle and her husband worked for many years on the Haselbusch Ranch, southwest of Oroville, near Hamilton Bend. The Indians held annual pow wows at the Bend 35 to 40 years ago, and Belle always attended.

Some of the mourners who attended her funeral at Sanford's Monday first became acquainted with Belle when she cared for them as children on the ranch. George Wirth, of the Wirth Ranch, remembers Belle and her husband as employes of his father's ranch many years ago.

What little fame ever came to Belle was gained through her ability to weave the colorful Indian baskets that decorate many of the ranch homes of this area even today. Her work has been exhibited all over the State of California as authentic artifacts of a vanishing race.

Little Is Known

The little that is known about Belle Rau today must of necessity be recorded through rumor. Having outlived her generation and her tribe, there is no one to record the faithful facts of her history

But her life spanned a period of the history of this area that will be a subject of study by students as long as the history of California is taught in the schools.

She watched the great monitors wash away much of the majestic mountains of her birthplace as the miners searched for gold. She was already a young woman when the Feather River was the mecca for thousands of gold seekers from all parts of the world.

She witnessed the losing fight of her people as they struggled to retain their lands and their independence against the on-rush of civilization. She sat silently by as the members of her tribe passed one by one from the scene until only she remained.

Joins Trek

And, finally, she too joined on the trek to the land of the Great Spirit where the campfires of her youth still burn brightly and the mountains and the forests still are fresh and green.

Her grave at the Cherokee Cemetery will be cared for by the descendants of those who knew her best. Her resting place will remain a monument of sorts to the era that marked the beginning, and later the end, of the great mining community of Cherokee where millions of dollars worth of gold was taken from the ground.

Pulga Man Dies In Cell at San Quentin Prison

OROVILLE (E-R) — Funeral services for Glenn Wood Teague, 36, of Pulga, who died in his San Quentin cell on March 21, will be held in Beaumont, Tex., Saturday.

Teague, who was due to be paroled from the state prison on April 13, had pleaded guilty to charges of conspiracy to commit forgery and was sentenced on Oct. 11, 1956.

The Pulga man's body was found in his cell and the San Quentin warden's office this morning told the Enterprise-Record that an autopsy had indicated the prisoner had died of natural causes. Exact cause of his death, however, was to be determined by examination of the doctor's findings, it was reported.

The warden's office said the autopsy definitely ruled out any possible foul play in Teague's death.

Last January, the Adult Authority set Teague's term at four years and granted him 18 months on parole. He would have left the prison on April 13 to begin the parole period.

Teague was one of a trio who burglarized the Utah Construction Company offices at Storrie, on Jury 1, 1956, and stole 2,500 blank payroll checks. They then set out to cash checks forged on the atolen blanks.

Francis Raymond Stanley. of Oroville, also pleaded guilty to the conspiracy charges, and was sent to San Quentin, while William Carson Rose, 33, of Oroville was convicted of forgery and was given a suspended prison sentence and placed on probation for a term of four years.

The Sanford Funeral Home here is handling arrangements for sending the body to Beaumont for the funeral services.

W. R. Patterson, Cherokee Native, Dies At Age Of 89



THE OLD HOMESTEAD — This is the home at the outskirts of the village of Cherokee where Ray Patterson was born nearly 90 years ago. The house was destroyed by fire a few years ago. It got the name "Old Homestead" after this picture had been taken by the Mercury in a Kamera Kranks competition and had won first prize. From then on the Pattersons called it by that name. William Ray Patterson, whose lifetime was spent side-by-side with nearly nine decades of Oro-ville's history, died Thursday, leaving a wealth of gold town memories with his wife, Laura.

Mr. Patterson was born the son of gold rush pioneers in Cherokee, March 24, 1871. He was 89 when he died in a local rest home.

In his youth, Mr. Patterson was a placer gold miner in Powelltown, Mosquito Creek and Yankee Hill. Later he became his father's partner in a Paradise grocery store.

In 1901, Mr. Patterson came to Oroville, and it was here that he became renowned in dredger mining as the "gold man."

Poured The Gold Bricks

It was he who took raw gold from the dredger boat processing tables and molded it into solid gold bricks.

As the rich ore filtered over the tables, which were similar in principle to the prospector's sluice boxes, the gold settled to the bottom of the table where it adhered to mercury.

The gold and mercury solution was taken by Mr. Patterson and retorted or melted. The mercury fumes burned off, and the pure gold was poured into iron molds. Mr. Patterson would take the bricks from Dredgerville, where he and his wife lived, into Oroville to the mining company office.

Gold In A Buggy

Mrs. Patterson remembers how her husband would place the bricks in flour sacks. The sacks, containing thousands of dollars in gold, would be placed between the couple on the buggy seat for the five or six-mile trip to town.

Mrs. Patterson recalls the nowvanished village of Dredgerville, where they lived for three years. Mr. and Mrs. Patterson were living there in 1907, when the banks of the Feather River overflowed in one of the biggest floods in history.

The Patterson house in Dredgerville was one of three that were not under water. During the high water days of the flood, the Pattersons took in 30 people whose homes had to be abandon-

Carried By Boat

Food from Chico was carried to them by rowboat.

In 1910, Mr. Patterson was forced to give up being the "gold man" because the mercury fumes impaired his health.

He then became a carpenter and worked in that capacity for the Natomas Consolidated Mining Co., for whom he had worked as gold man.

Remaining active throughout his life, Mr. Patterson became a cemetery superintendent and continued doing carpenter work.

He retired at the age of 75. He lived with his wife at 1455 Robinson St., until a few months ago when he entered the rest home.

Besides Mrs. Patterson, he is survived by several nieces and nephews.

Funeral services will be held Monday at 3 p.m. in Hamilton and Riley Funeral Chapel with the Rev. Mr. Leon Thomson officiating. Burial will be in the family plot in Cherokee Cemetery.
