Concow Board and Trustee Sued

Legal aftermaths of an altercation last fall between Elbert H. Legget, Concow school trustee, and former custodian-bus driver Harold E. Sloat has moved into superior court.

Sloat has filed a damage suit seeking \$2888 from the school district and board of education and \$12,888 from Legget. Also filed was an appeal by Legget from his conviction in Paradise district court.

Legget was found guilty of disturbing the peace while Sloat was found guilty of battery by Judge Kenneth H. Ohr last January. Both were placed on six months probation and given 30day suspended county jail sentences.

The charges grew out of an altercation on the school grounds involving the condition of the school following its use as an emergency fire fighting camp during a forest fire near Yankee Hill.

Sloat, in his first cause of action filed in superior court, sought \$2888 in salary he claimed was due him under a contract entered into with the school district which was to run until June 30, 1959. He was discharged by the school board last November 8.

In the second cause, Sloat charged Legget while acting in a private capacity and not as a member of the school board provoked a fight that led to his discharge. He also alleged Legget conspired with Ray Giles, another member of the school board, to have him discharged.

He sought general damages amounting to \$10,000, plus the \$2888 allegedly due him under his salary contract, from Legget.

Legget has appealed his conviction on the ground that three witnesses were not sworn before they testified at the hearing here, that a defense witness was not permitted to testify, and that there was no competent evidence before the court to show he was guilty of disturbing the peace.

Boy Survives 100 Foot Fall In FR Canyon

OROVILLE (E-R) — Richard Greer, 12, of Oregon City, fell 100 feet — the equivalent of a 10-story building — from a Table Mountain cliff onto the rocks of the rugged Feather River Canyon yesterday afternoon but is expected to survive despite multiple fractures.

Physicians, who performed emergency surgery for five hours last night and this morning, said it was a miracle that the boy had survived the fall.

A rescue team clambered swiftly in to reach the boy, who had fallen on a ledge. They then raced back at a dead run across the bottom of Morris Ravine to a waiting ambulance on Cherokee Road.

The total elapsed time of the rescue was about 1% hours. The swiftness of the rescue was credited with helping to save the seriously injured boy.

Richard and a friend, Robert Seveille, 13, also of Oregon City, rode their bikes yesterday afternoon after school to the rim of Table Mountain. Richard fell at about 4 p.m. while they were plaving. Robert rode his bicycle to a nearby ranch for help.

Richard's mother, Mrs. Woodrow Greer, watched anxiously from the top of the mountain as the rescue was made. She later collapsed after she saw her boy being loaded into the Weiss Ambulance service vehicle.

Community Hospital officials

this morning said Richard was in "satisfactory" condition and was getting along fine "considering his injuries." He has fractures of both arms and a bad fracture of the left leg, plus possible internal injuries.

He has been given transfusions to help alleviate apparent internal bleeding. X-rays were taken last night and casts put on his broken extremities.

Sheriff's Deputies John Berpa, of Chico, and Lawrence Rix, of Paradise, and County Jailer Glenn Arbuckle, of Chico, led a six-man jail trusty rescue team into the rugged area. One trusty was treated at Butte County Hospital for a slight leg injury incurred in the rescue.

Dr. E. P. Goddard, Oroville physician, accompanied the rescue team and treated Richard's injuries on the way to the hospital.

Physicians expressed the belief Richard would have died if the rescue had not been made so swiftly.

Dedication Set For Concow Park, Youth Campsite

PARADISE (E-R) — Sunday at 2 p. m. official dedication ceremonies will be held for Crain Memorial Park and the Soroptimist Organizational Campsite at Concow, under auspices of the Paradise Recreation District.

Invitations have been mailed to all representatives of youth groups in Butte County, and to various civic and governmental agencies, Director Harvey Roth announced.

The eight-acre parcel, beautifully wooded with meadow and stream flowing through it, was donated to the Paradise Recreation District by Mrs. E. Bolles in memory of her late husband, Donald Crain, a pioneer family member of Butte County.

Paradise Soroptimist Club members have for the past two seasons made development of a portion of the park as a campsite for youth groups their main civic project.

More than \$600 in club funds has been provided to furnish the initial ground preparation, culvert and road grading, installation of drainage, a concrete water storage system and piping for good water from a natural spring; installation of boys and girls restroom facilities, sturdy tables and benches, outdoor cooking stoves, a campfire circle with seats set into the hillside and a flagpole at the central area.

Youth and adults who wish to take part in the caravan or desire transportation are asked to assemble at the Recreation Center Sunday at 12 noon. The route is via the Nelson Bar Road to Concow and along the road leading to Concow Lake.

At 1 p. m., a tour of the area, and a walk to the lake, some 200 yards from the park, will be conducted.

The dedication program will begin at 2 p. m., with flag raising ceremonies, dedication prayer and group singing. A special march of youth around the campfire, during which each young person will add a piece of wood to the fire, will be held. Representatives from various

youth groups, such as Boy Scouts, Girl Scouts, 4-H Club, Pathfinders, Cubs, and Recreation youth groups will have a part in the ceremonies.

Prior to the campfire assembly, Soroptimist Club members, under the direction of Clara Brown, president-elect, and Alta Gillett, projects chairman, will unveil the redwood sign marking the youth campsite.

The dedication address will be given by Roy McKernan, a former member of the recreation district board of trustees, during whose tenure the project was launched.
